Together with other tourism marketing organisations, we signed the trilateral Sustainable Tourism Strategy on the occasion of the 12th Trilateral Governmental Conference on the Protection of the Wadden Sea in Tonder, 5 february 2014, because we are willing to share responsibility for conservation of our common natural heritage of 'Outstanding Universal Value' and for sustainable development through appropriate tourism management within our fields of work and according to our abilities.
