The submission of the trilateral State of Conservation Report (SOC Report) on the UNESCO World Heritage site "The Wadden Sea" was requested by the World Heritage Centre (WHC) in <u>Decision 45COM 7B.23</u> adopted by the World Heritage Committee at its 45th session (10-25 September 2023).

The trilateral Task Group World Heritage (TG-WH) and CWSS led the process of drafting the <u>2024 SOC</u> <u>Report</u>, which was submitted to the WHC in February 2024. The WHC also requested the TWSC to conduct a joint Strategic Environmental Assessment (joint SEA) to assess the cumulative impacts on the OUV of the property to be included in the SOC Report. As a joint SEA takes longer to prepare, it has been announced that it will be delivered as a separate product in approximately 2 years' time.

This document summarises the timeline followed for the development and submission of the SOC Report in 2023 and 2024 as well as further communication from and to the WHC, State Parties, and environmental NGOs, including the joint SEA as requested.

June – August 2025	Trilateral integration: Joint SEA.
August 2025	WSB approval of draft joint SEA for stakeholder participation.
September 2025	Plan Meeting on draft joint SEA with World Heritage Centre/IUCN.
End of 2025	WSB approval of final joint SEA and submission to World Heritage Centre.
